COMPETITION RULES

The competition will be carried out according to the UIPM Rules:

Swimming – 50 metre indoor swimming pool / 8 lanes

Fencing (Ranking Round) – 10 pistes indoor

Fencing (Bonus Round) – 1 show piste indoor

Riding – Grass

Laser Run – 38 laser precision targets (manufacturer: ALS), athletics track, tarmac and grass surface.

Please note:

Continental Championships for European Countries (ECMP members) only.

All delegations are allowed to participate with four athletes per gender.

The top 8 places - with a maximum of one (1) quota place per NOC - for women and men respectively earn an Olympic quota place for Tokyo 2020, according to "Qualification System – Modern Pentathlon – Tokyo2020"

COMPETITION VENUES

The competition will be held at: Sports Training Village, University of Bath
Claverton Down, Bath, England, BA2 7AY

TRAINING

The LOC will offer training facilities for swimming, fencing, shooting and running. The times of available sessions will be published closer to the event.

EQUIPMENT CONTROL

Equipment control will be carried out in conjunction with the programme outlined and further details will be given closer to the event.

ACCOMMODATION

Teams will be accommodated within Woodland Court Residence at the University of Bath. Woodland court is situated approximately 100 metres from the Sports Training Village.

All Technical Meetings and the LOC Office will be located within the Sports Training Village.

Only single, en-suite accommodation is available.

Accommodation will be arranged in groups of approximately 8-10 rooms with a communal kitchen and dining area provided. Wherever possible, members of the same delegation will be allocated rooms all within the same block.

Please note that all meals will be provided at the Lime Tree restaurant, which is approximately 50 metres walk from Woodland Court.

All delegates will be required to pay a small key deposit. This will be refunded when the key is returned upon departure.

NF's will be financially liable for any damage caused to rooms and their contents at Woodland Court.

TRANSPORT

Transport will only be arranged from and to **Bristol Airport** and **Bath Spa Train Station**. This will only be guaranteed if detailed flight information is entered into the UIPM Registration System in conjunction with the deadlines listed and the entry fees paid.

Bristol Airport is located 34km from the University of Bath and Bath Spa Train Station is 4km.

For teams choosing to fly into alternative airports, you will be responsible for arranging your own ground transportation accordingly.

Arrangements are in place for teams to arrive on or after 4 August and accommodation before this date cannot be guaranteed. Teams wishing to arrive earlier should contact euos@pentathlongb.org.

Car parking for teams can be arranged close proximity to the accommodation if agreed with the LOC in advance.

All competition venues are within walking distance of the accommodation and Bath City Centre can be easily accessed from the University by public transport.

FINANCIAL CONDITIONS

The costs for this competition are listed below and stated per room per night.

The prices listed include full board accommodation, ground transportation, training facilities and competition entry.

For anyone wishing to arrange their own accommodation, an accreditation fee must be paid per participant to the LOC. This is set at £60 (GBP) per day per person with a minimum payment of four days (£240). For this, lunch will be provided and ground transportation will be arranged in conjunction with the parameters outlined in section four.

Payment reference

DEADLINES

The UIPM online registration must be used to submit all entry and accreditation information. To assist with planning, the LOC would very much appreciate a notification of intention to participate by **16 April 2019** outlining your likely delegation number and requirements to euross@pentathlongb.org.

If we do not receive the payments and entry information in conjunction with the deadline listed, then we will consider your delegation as non-participating.

A 10% late payment surcharge will be added for delegations failing to adhere to the final payment deadline of **26 July 2019**. Please note that under no circumstances will cash payments be accepted to pay fees on arrival at the event.

Delegations are reminded

Following the final entry deadline, the team must inform the LOC at least seven days prior to arrival of any withdrawals. This is for competition planning purposes only and unfortunately we will not be able to issue any refunds for accommodation costs.

If, on arrival for the competition, the delegation has less athletes and/or team officials than listed on within their final entry information and has not informed the LOC at least 7 days prior to their arrival, then the NF will pay a fine to the LOC of 200 Euros for each person failing to come.

Following confirmation of the final entries, a NF must enter the competition with at least one pentathlete. Any NF failing to take part after having sent their final entries will pay a fine of 750 Euros to the UIPM.

ATHLETES' LICENSES/ RIDING ABILITY

Athletes are only allowed to participate in UIPM sanctioned events, if they are in possession of a valid UIPM issued Athletes License. Registration is not possible without a License Number. If an athlete does not have a license, they will not be allowed to take part in the competition.

You are kindly reminded of UIPM Rule 1.12.1 and its relevance to this competition is as follows: Pentathletes without riding ability listed in the database and without a letter/certificate from their NF confirming their ability to ride may compete at the competition in the qualification for the Final, but if they qualify for the Final, they must relinquish their place to the next placed pentathlete qualified rider from their group. Such Letter/certificate must be sent to up loaded on UIPM portal before registration and some video footage might be asked prior to the competition.

INSURANCE

According to UIPM Rules all members of attending delegations should insure themselves in case of accidental injury or illness. The organiser will not accept any responsibility financial or other, for any loss, injury or illness of any member of the delegation.

All competitors from qualifying countries should bring their EHIC (European Health Insurance Card) with them to show they are entitled to free emergency treatment in the UK.

CIVIC RECEPTION

A Civic Reception will take place. Further details about this will be provided closer to the event.

VISAS & VACCINATIONS

In general, no special immunizations or medications are necessary for travel to the United Kingdom.

If you are travelling from a country not listed within the European Economic Area then it is likely you will require a Visa for entry into the United Kingdom. Visas can be applied for up to three months prior to travel and further information can be found at <https://www.gov.uk/check-uk-visa>.

FIREARMS

Firearms licenses are not a legal requirement when bringing laser, air and CO2 pistols into Great Britain for competition purposes. Passengers bringing in these goods solely for use at the event can go through the green 'nothing to declare' channel on arrival in the UK.

It is important that you ensure that the pistol information is logged within the Registration System.
