COMPETITION RULES

The competition will be carried out according to the UIPM Rules:

- Swimming: 25m Swimming Pool 6 lanes
- Fencing: 10 pistes indoor / 1 piste outdoor.
- Laser Run: 20+2 precision laser targets (Pentashot Hit Miss Conect).
- Running course: sand and grass.
- Obstacles: Steps BigWheels Wall Rings Balance beam Wheels Monkeys Bars Finish Wall. Some obstacles may be optional for older age groups; detailed Obstacle Guidelines for Masters will be prepared and shared with them separately.

Financial conditions

- 135 € per person per day in a twin room.

ACCREDITATION FEE

- Entry fee 200 € per person (without accommodation and transfers). The registration fees in Individual and Relay covers:
 - · Competition meal (Saturday and Sunday).
 - Venue access and medical support.

Coach or accompanying person $40 \notin$ per person.

All entries submitted after 10 of June result in an increased price of 20%.

Each full package of entries (accommodation + competition entry) includes accommodation, breakfast (open buffet), lunch (lunch at the venue), local transportation from/to the event and shuttle from/to the Adolfo Suarez Madrid Barajas.

Each participant must pay an entry fee to the LOC.

TRANSPORT

Transportation from the airport to the official hotel and the return journey is only guaranteed if arrival information is provided in the registration system in good time and before the deadline. Only one transfer service per delegation is included in the participation fee. Extra airport shuttle is $65 \notin$ /one-way. Traveling is at your cost to and from Madrid.

ATTENTION! All extra costs for bank transfer must be paid by the participant. Paying cash upon arrival is only accepted if you have a written approval from the LOC to do so and all financial conditions (costs) will be calculated on the prices mentioned above.

PLEASE NOTE

As a reminder, if on arrival at the competition, teams arrive with fewer athletes, coaches and/or officials than submitted in the registration system and without informing the Organizing Nation/LOC at least 7 days before their arrival, the NF will have to pay a fine to the Organizing Nation/LOC of 200 \in for each person not attending.

DEADLINES

The confirmation of the participation will be open from 20th April 2025. All information must be submitted, including flight information and pistol serial numbers before 27th of May. Any changes after this must be sent by email to the organizer <u>euch25@pentatlon.info</u>

Any failure to take part having sent their final entries will pay a fine of 400€ to the LOC.

- All entries will be confirmed until 5th of June 2025.
- Closure of Registration: 11th June 2025 (Form "B")
- Deadline to transfer total amount: 20th June 2025

If we do not receive complete information about your delegation before the closure of the registration system or we don't receive your delegation's payment, confirmation then we will consider your delegation as non-participating.

Please strictly adhere to the deadlines. Entries received after the deadline will be considered case by case individually.

ATHLETES LICENCE'S ABILITY

Athletes are only allowed to participate in ECMP sanctioned events if they have a valid Athletes License. Registration is not possible without a License Number. If an athlete does not have a license, they will not be allowed to take part in the competition.

Such letter/certificate must be sent to upload on the UIPM portal before registration.

INSURANCE

According to ECMP Rules, all members of attending delegations should insure themselves in case of accidental injury or illness. The organizer will not accept any financial liability or loss, injury or illness that occurred to any participant and or member of the delegation.

Firearms licenses are not a legal requirement when bringing air and CO2 pistols (cylinders for laser pistols) into Spain for competition purposes.
